Secretary Chiavetta,

Within your correspondence dated November 16, 2023, there were 6 Data Requests at the end of your letter. Please see responses associated with each request, along with noted supporting documentation where applicable.

Request #1 Please confirm that all of the actions mentioned in Club Exploria's March 24, 2023 letter to Commission have been completed and explain any additional steps Club Exploria has taken to become non-jurisdictional and exempt from complying with Act 127.

I can confirm that the actions mentioned in letter of March 24, 2023 have all been completed. Please see attachment, "E mail to Jim Harchar 031523". As invited to do so in the letter, Jim Harchar, I believe it was Friday, March 24, 2023, when a site visit was conducted by Jim Harchar, Ryan Zaffino, and Mike Chilek, of the PUC, to verify the work was completed. It was at that time that Mike Chilek noted a Dashboard Card Notification allowing a vehicle to be parked on our Private Property where the general public is not allowed. Also, at that time a broken sign or sign in disrepair, related to ours being a private community, was noted. At that time, I told the gentlemen I would have it repaired and documented to you. Please see attachment, "E Mail to Jim Harchar 033123".

Request #2 Please provide the Act 127 Annual registration to the Commission ASAP. Alternatively, please provide the date this was filed with the Commission and the tracking information.

Please see attachment "Act 127 Registration Form Adjusted 112223" filed from Florida office 112923

Request #3 Please provide documentation or citations supporting Club Exploria's assertions that it would be exempt from the Commission regulations.

From Docket Number 15283 of the Propane Education and Research Council, located at 1140 Connecticut Avenue NW Suite 1075 Washington DC 20036. Titled "Propane Jurisdictional Systems A Guide to Understanding Basic Fundamentals and Requirements.

Page 2 Common Terms Jurisdictional System, "...when the system is not entirely on the customer's premises and a portion of the system is in a public place." All of the infrastructure associated with our propane is 100% on our own private property. Also, on page 2 of the publication it defines a Public Place, "A place that is generally open to all persons in a community as opposed to being restricted to specific person". We are 100% a private community, members only. Our basketball courts are even locked for members only. See again previous attachment indicating "Private Community".

Page 4 Defining a Jurisdictional System; Condition 1: Multiple Customers (10+ supplied from a single source). Our entire system has been reworked in 2023 whereby a single source serves no more than 8 of our own villas all owned 100% by Club Exploria. This condition does not apply.

Page 5 Condition 2: Multiple Customers, where a portion of the system is in a public place. This does not apply since we are not a public place.

Page 7 "When Is a System Non-Jurisdictional? A propane system is considered non-jurisdictional if it has fewer than 10 customers and no portion of the system is in a public place", Club Exploria has no customers. "Also it is considered non-jurisdictional If the system is located entirely on a single customer's premises (no matter if a portion is located in a public place)."

Continuing also on page 7, "A good example of non-jurisdictional system would be a single-family residence or a small condominium complex with fewer than 10 customers, if the condo association owns the roads within the complex or none of the propane lines cross public roads or rights-of-way (Example 1). Another good example would be a fast food restaurant where the propane tank(s) is on the customer's premises and the lines running under the driveway/parking area are also on the same customer premises. Because this is a single customer and the entire system is on the same customer premises, this entire system is non-jurisdictional (Example 2)." Club Exploria is the only "customer" here, we do not sell LP gas to anyone.

Request #4 Please provide documentation from the U.S. Department of Transportation's Pipeline and hazardous Material Safety Administration (PHMSA) that clearly designates Club Exploria as non-jurisdictional and exempts Club Exploria from the mandates of Act 127. This is the relief we are seeking.

Request #5 Please explain if any of Club Exploria's gas lines are in, or cross, any public areas. This has been documented as NO they do not exist in public areas.

Request #6 Please explain the types of entities/customers that Club Exploria's gas lines provide service to. The villas in the area that have gas appliances are:



Hope you are well, As far as the O&M manual goes there have been no upgrades or changes do you still want a copy? What has been done on our property is implementation of what was talked about last year, with yourself, Mike and Ryan, which is separating our system to the point we are no longer jurisdictional. This has been accomplished.

We have separated all of our multi-tank connections.

We have eliminated all interconnections of more than 8 Villa units on a system

We have set in place 5 additional tanks

We have several units that are no longer in service with no LP connectivity.

There are tanks that remain in the ground completely locked out and cut off from any pipe network

On the attached document you will see the old layout represented with yellow lines, this also shows all the interconnects, isolation valves, etc. The heavy black lines now show the system layout including the 5 new tanks placed, numbering 1-5. It then shows the route of the LP supply to the villas. No longer do we have the ability to supply one area with LP Supply from another, all interconnects are gone. Where the black lines end is where the LP service ends to those specific units.

Additionally Exploria Resorts will be getting out of the LP Gas purchase and self delivery business. We will be engaging the services of Heller's Gas to supply and deliver all necessary LP to our property. Exploria will continue to maintain the regulators and such to the villas.


We believe, at this point, and with the system changes we are longer a Pipeline Operator under Act 127. As part of being completely transparent I will file the annual registration, with all the system changes noted above, unless you advise it is not necessary to do so prior to March 31, 2023.

Jim, if it makes sense to you, feel free to come and meet with myself and John Smith and do a property tour. You can see the "scars" in the ground where tanks were added, lines eliminated, etc.





By this letter we wish to request that Club Exploria LLC-Pocono Mountain Villas, Utility Code #1721803, be removed from the Pa Act 127 Pipeline Operator Registry.

Over the past several months Club Exploria LLC has made numerous modifications and system changes, which we believe, warrant this request. Our original Act 127 Classification as Jurisdictional, was primarily due to the interconnect of 171 Villas on our private property here in Bushkill Pa via small gas distribution lines from several interconnected tanks. Our work over the past several months has resulted in the removal of all interconnected appurtenances between tanks, as well as, each of our tank locations, or propane sources, which now feed 8 villas or less, within our private community.

Club Exploria LLC has maintained an open dialogue with Jim Harcher, PUC Pipeline Safety Bureau of Investigation and Enforcement, as well as Michael Chilek, and Ryan Zaffino of the PUC. These gentlemen have made the effort to come to our property to witness our system changes. I do believe they will concur that this request to be removed from the Pa Act 127 Pipeline Operator Registry, is legitimate and warranted.

To be safe, Club Exploria LLC will be filing the Act 127 Annual Registration, prior to March 31, 2023. Neither myself, or Jim Harcher was absolutely sure how this procedure to remove Club Exploria LLC from the registry would take place, so to be safe, we will file. If you were to access this latest filing you will note a brief description of pipeline removed as well as the villa count from a single source.


