

To whom it may concern:

The purpose of this Letter is to advise you that your application has been reviewed and approved by the Pennsylvania Public Utility Commission (Commission). However, before you begin operations, you must file with the Commission all of the documents/forms listed in the paragraphs below. **You cannot operate under the approved motor carrier rights set forth in this Letter until all of the documents and/or forms listed below are filed with, and approved by, the Commission.** Once the items listed below are received *and approved* by the Commission, you will receive a certificate of public convenience, with PUC No. A- 00118107, which authorizes you to begin operating under the rights set forth in this Letter.

- a. An acceptable **Form E and Form H** filed by an insurance company which is binding evidence of bodily injury and property damage liability insurance. **Your insurance company must file these forms with the exact name of the applicant as it appears on this Letter – M & A TRANSPORT INC. The State MC A-00118107 must be listed to identify your account.** All service types covered by this policy must be listed. Insurance filings are accepted online via Tyler Insurance Filings at www.tylerinsurancefilings.com
- b. An outstanding fine for this utility code from 4/24/2013 (at docket numbers C-2013-2359282, respectively) of \$500, must be paid in full. Please reference the attached insurance default letter.
- c. Due to the applicant's previous history of non-compliance with Commission regulations, the applicant is required to provide a detailed statement/plan indicating what steps it has/will take to ensure constant compliance with the Commission's insurance and assessment filing requirements. The submission should be verified

per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses: I, Linda Silvasan hereby state that the facts above set forth are true and correct to the best of my knowledge, information, and belief, and that I expect to be able to prove the same at a hearing held in this matter. Enter your company name, click submit, then click on your utility code hyperlink. Navigate to the "Insurance Info" tab, where you can view accepted forms.

Upon issuance of a Certificate of Public Convenience you are granted the right to operate as follows:

To transport, as a common carrier, by motor vehicle, property, excluding household goods in use, between points in Pennsylvania.

FAILURE TO COMPLY WITH ANY PROVISION OF THIS LETTER WITHIN SIXTY (60) DAYS OF THE DATE OF THIS LETTER WILL RESULT IN THE DISMISSAL OF THE APPLICATION AND REQUIRE THE FILING OF A NEW APPLICATION AND FILING FEE.


If you have not previously submitted a copy of a current satisfactory safety rating from the U.S. Department of Transportation or another state with safety regulations comparable to Pennsylvania, you must demonstrate safety fitness by completing a Safety Fitness Review which will be scheduled by a PUC enforcement officer within 180 days of the date your certificate of public convenience is issued/entered. Failure to submit to the Safety Fitness Review will result in the cancellation of your certificate. An overview of the safety regulations for carriers of people, property, and household goods between points in Pennsylvania can be found on the PUC's Website.

You should become familiar with the requirements of 52 Pa. Code as applicable to the operation of a common carrier as authorized by this grant of authority. Any change in address must be reported to the Commission by filing a Change of Address Form. This form can be found on the Commission's website.

Failure to comply with all applicable requirements may subject the carrier to penalties, including fines, suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed at www.pacode.com.

On April 24, 2013, the Bureau of Investigation and Enforcement instituted a Complaint against Respondent, for failure to maintain evidence of Cargo insurance on file with this Commission, a violation of the Public Utility Code at 66 Pa C.S. §512, 52 Pa. Code §32.2(c), and 52 Pa. Code §32.11(a), §32.12(a) or §32.13(a).

In accordance with 52 Pa. Code §5.61, the Bureau of Investigation and Enforcement notified the Respondent that, unless the insurer files evidence of insurance with this Commission, and Respondent pays the proposed fine, an Answer to the Complaint must be filed within twenty (20) days of the date of service. The Notice further specified that, if Respondent failed to answer the Complaint within twenty (20) days, the Bureau of Investigation and Enforcement would request that the Commission cancel Respondent's Certificate of Public Convenience.

The Complaint was mailed by certified mail on April 24, 2013, which was delivered and served on April 26, 2013. To date, more than twenty (20) days later, respondent has failed to file an Answer to the Complaint and has failed to pay the fine and have its insurer file evidence of insurance with this Commission.

Therefore, the allegations in the Complaint are deemed to be admitted. The Complaint is hereby sustained and the **Certificate of Public Convenience**, issued to Respondent at A-00118107 is **hereby canceled**.

Respondent is assessed a fine of \$500 for failure to maintain evidence of insurance on file with this Commission as required at 52 Pa. Code §32. Payment must be made by certified check or money order payable to the **Commonwealth of Pennsylvania** and mailed to PA Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until all

past due assessments are paid, all past due fines are paid, all insurance filings are up to date, and it holds an active Certificate of Public Convenience issued by this Commission.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§1.1 et seq. and the regulations of the Commission, 52 Pa. Code §§1.1 et seq. In view of the **cancellation of respondent's Certificate of Public Convenience**, it is specifically prohibited from rendering service as a common carrier by motor vehicle in intrastate commerce in the Commonwealth of Pennsylvania.

Should Respondent wish to again begin transportation operations in the Commonwealth of Pennsylvania, Respondent must file a new application for authority in order to obtain a Certificate of Public Convenience. The Respondent must pay all outstanding assessments and fines before this Commission will act on an application for authority. Payment must be made by certified check or money order payable to the **Commonwealth of Pennsylvania**, and mailed to PA Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265.

If you disagree with this determination you may appeal to the Commission, pursuant to 52 Pa. Code §5.44 or, if you believe that you have received this letter in error, you must write a letter stating the reasons you believe this letter is in error and requesting that it be rescinded within 20 days of the date of this letter. The letter shall be sent to Secretary, PA Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265.
