Dear Secretary Chiavetta:

In accordance with Section 5.592(a) of the Public Utility Code, please find enclosed the filing of FirstEnergy Pennsylvania Electric Company ("FE PA") in compliance with the Order of the Pennsylvania Public Utility Commission ("Commission") entered in the above-referenced proceeding on December 7, 2023 ("Consolidation Order").

In accordance with Ordering Paragraph No. 8 of the Consolidation Order, which provides that the Tariffs are "to be effective on one-days' notice after Commission Order approving the Settlement", FE PA is filing these new tariffs reflecting the approved tariff shown in Appendix A to the Joint Petition for Settlement of All Issues to become effective on January 1, 2024. The attachments include the Consolidated FE PA Tariff, the Consolidated FE PA Supplier Tariff and the Consolidated FE PA Third Party Data Tariff. Pages 114-119 on the Consolidated FE PA tariff, which contain the Met-Ed rate district Street Lighting rates, were inadvertently omitted from the Settlement agreement filing.
