

Pursuant to Pa. Code §63.104(c), the Applicant is not proposing to tariff its IXC services. However, information pertaining to the rates, charges, terms and conditions for its competitive services is available for public inspection at 601 N. Country Fair Dr., Champaign, IL 61821. Furthermore, the Applicant is not proposing to bill other carriers for terminating/originating access charges. Therefore, no Switched Access tariff is proposed.

Please note that a future transaction is planned in which MIP VI Trainer, L.P., which currently holds a 45% interest in Pavlov Media, CCG's parent, will purchase a portion of other shareholders interests in Pavlov Media, and will then have a greater than 50% interest in Pavlov Media. While the Transaction will result in a change in the ultimate ownership of CCG, it will not involve any assignment of licenses, assets, or customers. CCG will continue to provide service to its existing customers under the same name, rates, terms, and conditions and without any interruption of service. CCG will subsequently file an application for transfer of control with the Commission at the appropriate time.
