On December 7, 2023, the Pennsylvania Public Utility Commission (“Commission”) entered an Order at Docket Nos. A-2023-3038771, *et al.* approving, among other things, the merger of Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company, and West Penn Power Company (“West Penn”) into FirstEnergy Pennsylvania Electric Company (“FE PA”) with FE PA as the surviving entity.

The closing of that merger transaction took place on January 1, 2024. As such, the applicant in the above-referenced proceeding is now FE PA, not West Penn.

Accordingly, FE PA respectfully requests that the Commission, presiding Administrative Law Judges, and parties reference FE PA instead of West Penn and use the following case caption going forward:
