1. By Call In Telephone Hearing Notice (“Notice”) dated November 15, 2023, the Commission scheduled a hearing in this matter on Friday, January 12, 2024 at 10:00 a.m. before Administrative Law Judge Eranda Vero.
2. PGW was not served with the Notice via first class mail or eservice.
