**Status Report**

Dear Administrative Law Judge DeVoe:

In response to the Interim Order Directing Parties to Submit Status Report, issued on January 2, 2024, Veolia Water Pennsylvania, Inc. ("VWPA") files this status report.

Since the Parties' Joint Status report filed December 8, 2023, the Office of Consumer Advocate ("OCA") served VWPA with discovery, which VWPA answered. VWPA circulated a settlement term sheet. On January 12, 2024, the OCA circulated a counter-offer to VWPA's settlement proposal. Also on January 12, 2024, the Office of Small Business Advocate advised VWPA and the OCA that it cannot enter into a settlement.

VWPA is interested in exploring options for resolving this matter without the OSBA joining the settlement. VWPA respectfully requests that a status conference be held in approximately thirty days so the parties can discuss whether this case must be litigated and, if so, establish a litigation schedule.
