Please find the payment for Consolidated Edison Energy Inc's NGS Supplement Fee Invoice of six hundred and fifty-one dollars (\$651.00) enclosed.

Please note that as of March 1, 2023, RWE Renewables America (RWERA) announced an agreement to acquire the Con Edison Clean Energy Business, Inc (CEB). The integration of the two companies is complete and, moving forward, RWE Renewables Americas will operate as RWE Clean Energy, a wholly owned subsidiary of RWE AG (RWE).

Please also note that the relevant RWERA and CEB operating companies were effectively renamed as of March 1, 2023 as follows:

At the time of writing, RWE Clean Energy Wholesale Services, Inc is in the process of completing the name change application with PA PUC. RWE Clean Energy is currently waiting on the return receipts from the five (5) agencies, Columbia Gas, and UGI.

Of note: Consolidated Edison Energy Inc has undergone a name change to RWE Clean Energy Wholesale Services, Inc. All other characteristics of the company, including the Federal EIN, remain the same.

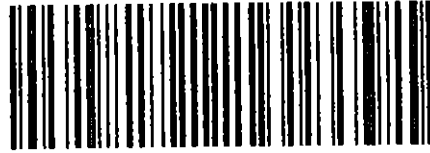
