COMES NOW, Higinio Mendoza, Jr, Sui Juris, and Karen Feitt, Sui Juris, to move the court to COMPLAINTS ANSWER THE PETITION FOR RECONSIDERATION AND REVERSAL in the above-named case number 2022-3037095. The Sovereign move the court to answer questions, recorded hearings held by an alleged *Administrative Law Judge*. Furthermore, hearings held by the *PENNSYLVANIA PUBLIC UTILITY COMMISSION* Judges, Commissioners concurred OPINION AND ORDER to close the case, therefore the following reasons are set forth below.

AFFIDAVIT

The following statements are sworn testimony, before God, as stated.

1. In the fall of the year 2022, the Claimant sent a complainant (notice of a billing error) to the Respondents place of business, and the *Attorney General of the State of Pennsylvania* for mediation of the claim. Respondent refused mediation at the Attorney General of the State of

Pennsylvania place of business.

2. Thereafter, on November, 2022 a private invitation by the Respondents legal department place of business for a recorded meeting consisting of settling the matter for a resolution that the bill is in error (billing error), and the Claimant expressed his position as beneficiary of the trust, furthermore the bill is in error, lacks correctness within Respondent monthly statement of account, billed for payment. The conclusion of that meeting was inconclusive, and the Respondent extended an invite to the process at the *PENNSYLVANIA PUBLIC UTILITY COMMISSION* for the possibilities of closer.

3. Recorded hearings by the *PENNSYLVANIA PUBLIC UTILITY COMMISSION*, Commissioners, and by the *Administrative Law Offices/ Judge* concluded with opinions and orders to close the case. However, Complainant pleaded consideration regarding the facts of the case, and on December 15th, 2023 complaints petition for reconsideration filed was granted.

4. On December 28th, 2023, the Sovereign forwarded to *PENNSYLVANIA PUBLIC UTILITY COMMISSION*, Commissioners (Et al) an AMICUS CURIAE LETTER established by a global postal union treaty. Complainant forwarded amicus curiae letter compelled the STOPPING AND CORRECTING WRONGS with other titles that are standard codes of conduct, titles recognized by the *PENNSYLVANIA PUBLIC UTILITY COMMISSION* authority. Although the Respondent has stated the *COMMISSION* lacks jurisdiction of standards for certain titles, codes of conduct those specific laws must be considered as they are recognized by other legal public servants, and serve as effective tools allowing restitution in the administration of justice, and equity.

5. Amicus-Curiae-Letter Paragraph 0 states that I am a witness to the fact and it is your duty to stop, correct, come into joinder with the Postmaster General of the World as it pertains to the Respondents corporation and business matter. Paragraph 1 states that I am a witness to the fact that the United States as well as all United States Military Postal Branches, Congress/House/Senate, Treasury, Presidents, and Postal Service ended. Corporations and Military constructs go through the Post Office for authorization, and the Universal Postal Union Corporate capacity ended in July of 2001. Since 1999, without joinder with Postmaster General:

Russell-Jay: Gould you don't have authorization to function. Paragraph 2 states that I am a witness to the fact that you now have the comprehension of the facts stated in the first two paragraphs. With these learnings, you now have a duty under knowledge to come out of your rogue condition and stop and correct. As stated in the contents of the Amicus-Curiae-Letter mailed for the best closure.
