
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

▲ **NOTE 3 - Travel Time Charge** - When the combined distance from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal is:

- A. 0 miles to 20 miles - flat charge shall be one-half (1/2) hour at the applicable rates.
- B. 21 miles to 40 miles - flat charge shall be one (1) hour at the applicable rates.
- C. 41 miles to 60 miles - flat charge shall be one and one-half (1 1/2) hours at the applicable rates.
- D. For distances in excess of 60 miles, add one-half (1/2) hour for each additional 20 miles.

NOTE 4 - When a piano or safe is included in a shipment, the following additional charges will apply per each piano or safe:

Spinet Piano-\$255.00; Baby Grand Piano-\$350.00; Grand Piano - \$450.00; Safe - \$250.00

▲ **NOTE 5 - WAIVER OF MINIMUM CHARGES - CARRIER CONVENIENCE:** Carrier shall not assess a minimum charge (number of hours) whenever a move takes less time than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time necessary to complete the move plus the applicable travel time charge.

*The following notes are in lieu of rates shown in Tristate 51-W and are applicable on shipments traveling between points in Pennsylvania and transported in excess of forty (40) miles:*

NOTE 6 - MINIMUM WEIGHT CHARGE (Rule 33) - The minimum weight for shipments transported 100 miles or more will be 4,500 pounds.
