

- 1.) Question #3 of the Verified Statement of Applicant asks the applicant to provide evidence of minimum of two-years' experience with a licensed household goods carrier or the equivalent as required by 52 Pa. Code §3.381(c)(1)(iii)(A)(II)(-1-), you proceeded to put "Patio.com – Supervisor Benjamin Espinal, Game 7 – Andrew Bubineck 347-791-4929 973-886-2133." This is not evidence of employment with a licensed household goods carrier or the equivalent.
  - a. You will need to provide evidence (such as, a notarized letter from a previous employer or W2 showing that you have worked with a licensed household goods carrier or the equivalent.)
  - b. If you have not worked for a licensed household goods carrier for the required two-years, then you will need to show evidence that you have received the equivalent experience. This experience should be thorough, and demonstrate that it is the equivalent to two years' experience working with a licensed household goods carrier.
  
- 2.) You failed to adequately answer all aspects of question #5 of the Verified Statement of Applicant. Please review Title 52 Pa Code §29.501-509 Driver Regulations to see what is required of motor carriers.
  - a. Your system for conducting criminal background checks.
    - i. How often will the criminal background checks be conducted?
    - ii. How will you maintain records of the criminal background checks performed?
  - b. Your system for conducting driver license checks?
    - i. How will you be conducting your checks of driver licenses for drivers?
    - ii. How often will these checks be performed?
    - iii. How will you maintain records of such checks?
  
- 3.) In the submitted Statement of Financial Position (Balance Sheet), you list 10,000 in total assets, but list nothing for Cash or Other Current Assets. Please resubmit a corrected Balance Sheet that identifies what the \$10,000 in assets is from.
