Request for Information

- 1.) In your application you mentioned for your experience as “Patio.com – Supervisor Benjamin Espinal, Game 7 – Andrew Bubineck 347-791-4929 973-886-2133.” In the first Commission data request you were informed that this was not evidence of employment.
 - a. In your response to the previous data request, you included W2s for Scott Waters and Marley Cherwin-Zangwill for their time working for Prime Staffing LLC. Are you saying that you gained the required two-years’ experience with a licensed household goods carrier or the equivalent through their time working with Prime Staffing LLC? If so then you will need to show evidence that this experience is the equivalent to two years’ experience working with a household goods carrier.
 - i. What exactly does service does Prime Staffing LLC provide?
 - ii. What were your duties with Prime Staffing LLC, and how exactly does this translate to the experience that you would have gained working with a licensed household goods carrier in the moving industry.
 - b. Also, in your response to the Commission data request you mentioned that you gained the required experience “over the past few years...working with an agency called Game Seven.” This is a statement and does not rise to evidence of experience.
 - i. Please provide evidence that you gained the equivalent experience working with Game 7 for the required two years, such as W2s, and notarized letter from this employer detailing your duties while working for them.
 - c. Additionally, in your response you also stated that you are working on getting a notarized letter from Rabbit Movers. Since they have not been previously mentioned, who is Rabbit Movers, and what is your connection to them? If you are going to be citing them as experience, then you will need to provide evidence in such that has been previously mentioned.
- 2.) You failed to answer Question #3 of the previous data request. In the submitted Statement of Financial Position (Balance Sheet), you list 10,000 in total assets, but list nothing for Cash or Other Current Assets. Please resubmit a corrected Balance Sheet that identifies what the \$10,000 in assets is from.
