NOTE 1 - MINIMUM TRANSPORTATION CHARGES (PEAK SEASON) - The Minimum Transportation Charges (Non-Peak Season) will apply with the following exceptions: The last 5 days of each Peak Season month, will have an 6 hours minimum. Crews of van & 2 men during Peak Season will have an 6 hours minimum on all calendar dates. Crews of van & 3 men during Peak Season will have a 4 hours minimum on all calendar days except for the last 5 days of each Peak Season month.

MINIMUM TRANSPORTATION CHARGES (NON-PEAK SEASON) - Sundays and Holidays (any hour): 6 hours at rates named in Columns 1 and 2. Saturdays (any hour) and Weekdays (5:01PM to 6:00AM): 6 hours at rates named in Columns 1 and 4. Weekdays (6:01AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 2 - Any move using a crew in excess of 3 men will have an additional transport flat charge of \$40.00.
