TOWN & COUNTRY MOVING & STORAGE

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Subject to Notes AA, BB, CC and 1 and 2 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

▲ NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) and Weekdays (5:01PM to 7:00AM): 8 hours at rates named in Columns 1 and 4. Weekdays (7:01AM to 5:00PM): 8 hours at rates named in Columns 1 and 3.

NOTE 2 - Rates in Column 4 apply only from 5:01PM to 12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE AA - A flat charge based on one (1) hour at the applicable transportation rates shown in Columns 2, 3, and 4 is applicable when the combined distance from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal is 30 miles or less.

NOTE BB - A flat charge based on one and one-half (1 1/2) hours at the applicable transportation rates shown in Columns 2, 3 and 4 is applicable when the combined distance from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal is 31 to 60 miles.

NOTE CC - When the combined distance from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal exceeds 60 miles, NOTE BB will apply plus a charge equal to one-half (1/2) hour at applicable rates shown in Columns 2, 3, and 4 for each additional 15 miles over 60 miles.
