Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective April 1st, 2024, for Exclusive Services, Inc., t/a Don Farr t/a Don Farr Moving & Storage (PA PUC Certificate #A-8922932) in West Mifflin PA.

The attached pages are 626th Revised Page 2, 277th Revised Page 2-A, 2nd Revised Page 32, 1st Revised Page 32-A-1, and 1st Revised Page 32-A-2.

This filing is a request for an **INCREASE** in local hourly rates for shipments transported 40 miles or less, a **CHANGE** to using SCHEDULE D for packing/unpacking labor at all points in Pennsylvania, an **INCREASE** in the environmental fee, and an **INCREASE** in Full Value Protection rates.

The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

The Issue Date for these changes in Tristate 54 is March 1st, 2024, with an Effective Date of April 1st, 2024.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Saturdays and Holidays: three (3) hours at rates named in Column 2 plus applicable travel charge.

NOTE 5 - Minimum Transportation Charge: Sundays: three (3) hours at rates named in Note 8 plus applicable travel charge.

NOTE 6 - When services commences on a weekday, at the request of the shipper, after 5:00PM or before 6:00AM, rates shall be as shown in Column 4 plus applicable travel charge.

NOTE 7 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from the time of arrival of vehicles and men at the first point of origin until completion of unloading and dismissal of vehicles and men at the final destination unless other time of arrival or dismissal is provided by agreement between the shipper and the carrier.

◆ NOTE 8 - SPECIAL - overtime rates will apply when work is performed on Sundays:

Vehicle/Driver - \$110.00 per hour; Additional Men/Laborer - \$70.00 per hour; Supervisor - \$110.00 per hour

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.

0-15 miles	1/2 hour
16-30 miles	1 hour
31-45 miles	1 1/2 hours
46-60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.

▲ Item 1 - In lieu of rates shown for packing & unpacking in Tristate 50-T, Item 301, and Tristate 51-W, Item 110, Schedule D rates shall apply for all points in Pennsylvania. Rates shown in Tristate 50-T, Item 310, and Tristate 51-W, Item 115, shall apply for containers at all points in Pennsylvania.

◆ Item 2 - ENVIRONMENTAL FEE: **\$30.00 PER SHIPMENT** (this charge applies on all shipments traveling between points in Pennsylvania transported 40 miles and less and transported in excess of 40 miles.

Item 3 - Additional Transportation Charge (ATC): Applicable in all counties within the Commonwealth of Pennsylvania at both the first point of origin and the final destination. The Additional Transportation Charge will be calculated at a rate of **\$4.00** per 100 pounds in both the origin county and the destination county on shipments transported in excess of 40 miles utilizing tariff, Tristate 51-W.

Item 4 - When customer requests shipment be held overnight in lieu of storage or SIT, the following charges will be applied per vehicle:

Straight Truck	Each Night	\$200.00
Trailer	Each Night	\$200.00

These charges apply to shipments transported between point in Pennsylvania travelling 40 miles and less or in excess of 40 miles.

Item 5 - In lieu of rates shown in Tristate 50-T and Tristate 51-W, the following rates will apply for Carrier Servicing of appliances or other articles.

Rates shown apply at both origin and destination (as applicable):

First Article - **\$23.05** per article

Each Additional Article - **\$16.75** per article
