PHILADELPHIA GAS WORKS’ MOTION TO CONTINUE

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Tuesday, March 5, 2024. In support of this Motion, PGW states as follows:

1. By notice dated January 2, 2024, the Commission scheduled a telephonic hearing in this matter for Tuesday, March 5, 2024 at 10:00 a.m., before Administrative Law Judge Darlene Heep.
2. In his Complaint, Kingsley Donaldson (Complainant”) indicated that he is disputing the accuracy of his bills for gas service.
3. PGW is still in the process of investigating the issues raised by the Complainant relating to accuracy of his bills.
4. PGW is in the process of coordinating with the property manager to gain access to the property to exchange the meter for testing.
5. PGW will not be able to conclude its investigation into the accuracy of the meter prior to the scheduled hearing date.
6. PGW has spoken with the Complainant via telephone to discuss PGW’s request for a continuance in this matter; the Complainant has stated that he has no objection to PGW’s request and agrees that the matter should be continued so that PGW may conclude its investigation.

WHEREFORE, PGW requests that the hearing scheduled for Monday January 22, 2024, in the above captioned matter be continued.
