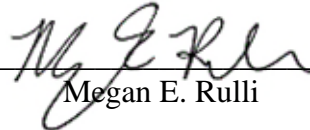


CERTIFICATE OF SATISFACTION
