**MOTION FOR CONTINUANCE OF HEARING DATE**

PECO Energy Company ("PECO"), pursuant to 52 Pa. Code §1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. A telephonic hearing in this matter is scheduled to take place on Wednesday, March 13, 2024 at 10:00 a.m.
2. PECO is requesting a two (2) week continuance of the March 13, 2024, hearing date because Respondent's expert witness, senior manager of advanced grid operations, Glenn Pritchard, who will testify to the Complainant's case, is unavailable March 11, 2024 through March 27, 2024, due to pre-planned business travel. Mr. Pritchard will be available as of March 28, 2024 and thereafter, excluding April 18, 2024 and April 19, 2024.
3. PECO therefore respectfully requests a continuance from the Hearing date.
4. This is the respondent's first Continuance request in this matter.
5. The Prehearing Order in this matter states that requests for a continuance are only granted where "good cause" exists.
6. PECO avers that "good cause" exists to continue the scheduled hearing to another date because PECO's witness was involved in PECO's initial deployment of smart grid and advanced metering infrastructure and is an expert in the design, operation and deployment of

smart grid advanced metering systems. He is the only witness available to testify to PECO's findings.

7. PECO has informed the Complainant that a continuance will be requested.
8. The Complainant has an objection to the Continuance request.
9. PECO respectfully requests that the hearing be continued to a further date.
