Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective April 1st, 2024, for Keystone Relocation, LLC (PA PUC Certificate #A-00121721) in State College PA.

The attached pages are 628th Revised Page 2, 213th Revised Page 2-B, 11th Revised Page 61, 2nd Revised Page 61-1, 7th Revised Page 61-A, 4th Revised Page 61-A-1, and 2nd Revised Page 61-A-2.

This filing is a request for an **INCREASE** in local hourly rates (Non-Peak Season & Peak Season) for shipments transported 40 miles or less, the **ADDITION** of a convenience fee when paying by credit card, an **INCREASE** in handling fee for pianos and safes, an **INCREASE** in the cost of TV cartons, an **INCREASE** in the overnight holding fee, an **INCREASE** in transportation rates (Non-Peak Season & Peak Season) for shipments transported in excess of 40 miles, and an **INCREASE** in the cost of dish-packs & corrugated containers on Page 61-A-2 (all other container rates remain the same).


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 2 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

NOTE 3 - When a holiday falls on a Saturday, rates named in Columns 1 and 2 shall be applicable.

NOTE 4 - Rates named in Columns 3 and 4 apply only from 6:01AM to midnight on any day when a higher rate is shown for the following day.

▲ NOTE 5 - A convenience fee will apply as follows, when customer requests using a credit card for payment: For shipments transported 40 miles or less and charges are \$700.00 or more - **\$39.00**. For shipments transported over 40 miles and charges are \$1500.00 or more but less than \$4000.00 - **\$59.00**. For shipments transported over 40 miles and charges are \$4000.00 or more - **\$125.00**.

NOTE AA - A travel charge will apply on all local residential moves in an amount to be determined as follows:

If mileage from carrier's facility to point of origin and from final point of destination to carrier's facility exceeds 60 miles, the additional travel time charge will be based on 1/2 hour per each additional 20 air miles.
