MOTION TO ADMIT EXHIBITS

Pursuant to § 5.402 and §5.404 I Mr. M. Hillman hereby offer exhibits to be admitted into evidence. I should be entitled to use them for purposes of showing that Aqua's records are untrustworthy. (See U.S Supreme Ct ruling Artis v, District of Columbia.)

Plaintiff Exhibits A, E, & G, served January 9, 2024, in preparation for the January 16, 2024, hearing.

- 1- My Exhibit A consist of the same information as Aqua's report, respondent ex-9. Aqua uses this report in their respondent ex-6 p. 14 & 15 (of 16). Also, this report can be found in aqua's judgment on the pleadings (twice) dated June 7, 2023.....along with my ex #1 a four page complaint.
- 2- Exhibit A par-1 aqua claim to have received certified letter on 2/28/19, (not true).....also claiming six accounts at the property (not true). "Also claiming, on 3/22/19 I called them stating the fsr did not check for foreign load, actually I called them 3/18/19, to report this, while he was on the property (so its not true) (see exh, mh-6 ..p.7 of 15)
- 3- On Exhibit-A par-2 Aqua did not have access to the radiator at that time.....(is not true),Both fsr employees entered the basement 12/4/18 and 3/18/19. Claiming aqua scheduled an appt with landlord(LL) and Mr. Hillman for 4/22/19 to verify the potential foreign load.....I believed was at the property (not true). This is but a portion of the inconsistency on this record.
- 4- My exhibit E for the January 16, 2024 hearing is the same record as aqua's respondents ex # 2, hearing dates May 16, 2023 and June 27, 2023. Aqua's records are claiming that Keith Biel made a worksite visit on March 21, 2019 (at Lincoln ave). There was no site visit that day the photos were taken on April 3, 2019.(exh 13a-13g)(MH-4).
- 5- Exhibit G for January 16, 2024 hearing is a 3-day shut-off notice that would pertain to Aqua's record keeping. A tenant living in the apt for months & months (using water & other utilities) and aqua records do not indicate who it is. Exhibit 14f shows aqua marks at the curb changing letter E to letter R and shifting E elsewhere, just prior to our moving out.

6- The Court requested color photo exhibits, possibly because Kieth Biel was identified with having a blue jacket (exhibit-13c). So, I would like to offer a more identifying color photo to be admitted into evidence. (exhibit 13g).

7- Exhibit 13f also shows 5 water boxes/shut-off valves at curb.

8- Exhibit #9 foreign load water supply ...shut-off valves

RESPONDENT EXHIBITS #11

9- RE: EXHIBIT MH-4, This is Aqua record of a work site visit that never occurred, Keith Biel visit was on April 3, 2019 (identical record to my exhibit E)

10- RE: EXHIBIT MH-5, P. 2 OF 15..... approx the 7th line of aqua record, I ask how many units or apts do Aqua service at the location "I advise 5 (5-accounts) only my apt is active, although the apts are occupied. This proves foreign load, and also on my exhibit A aqua records claim there are six accounts

11- RE: EXHIBIT MH-6, P. 7 of 15.....This is the work site visit on March 18, 2019, I called Aqua prior to the hostile (fsr) John Carr showing up and I called them while he was on the property----contrary to Exhibit A which claims I called on 3/22/18. The water meter is located in the basement, (with access to radiator,+ foreign load) and he showed me which meter was ours.

12- RE: EXHIBIT MH-7, P. 10 of 15.....Advised me that my hotwater heater has nothing to do with Aqua. I explained the Boiler heater and hotwater heater to them just as I did on December 9, 2022. and I was told the sameproves they ignored me here also----until being forced to recognize it on 4/22/19

13- RE: EXHIBIT MH-8, P. 13 of 15.....W. Kelly asked me what time would I be available for an inspection----He claimed the (fsr) Jason Jackson would be calling me to confirm, but that never happened---So, the plan was to sneak in at 11:30am, quickly, for 30 seconds (inconsistency)

Here are some of the codes that Aqua is in violation of: 52 pa codes §56.1, §56.141, §56.151, § 65.3, § 65.7, § 65.10, Chapter 69, and 66 Pa code §701, §1501, §1502, § 1504, § 1505, § 3301, § 3302, and § 3309. (sections 1501 –1505 describing the standards of service and facilities etc.)


'At some point, wastewater was mentioned because we were constantly plunging our bath and kitchen sinks practically every day, due to foreign load.



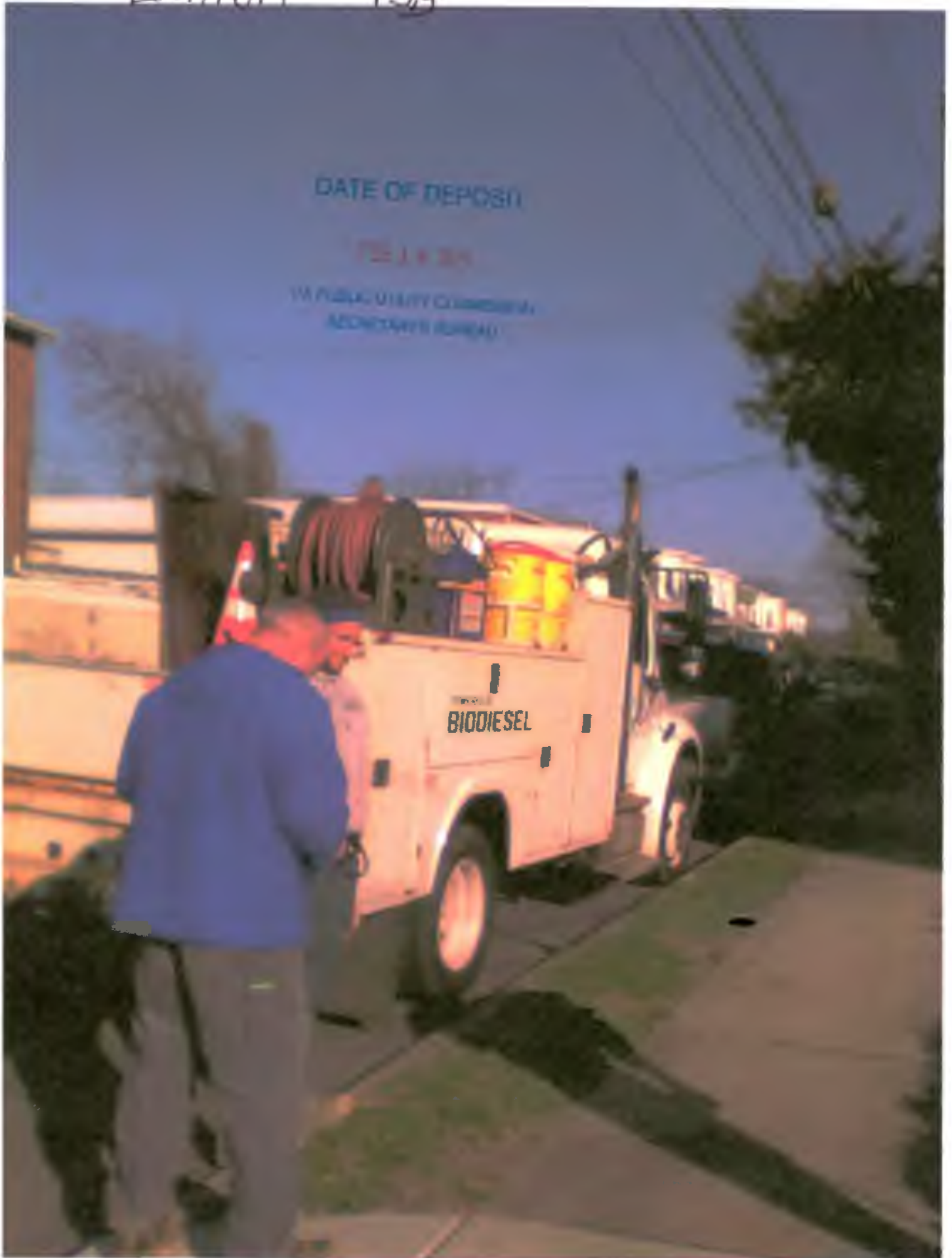

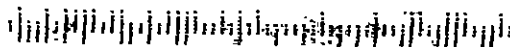
