

**COMPLAINANT'S ANSWER TO MOTION OF FIRSTENERGY PENNSYLVANIA
ELECTRIC COMPANY ON BEHALF OF ITS MET-ED RATE DISTRICT FOR
SUMMARY JUDGMENT**

TO DEPUTY CHIEF ADMINISTRATIVE LAW JUDGE EMILY DEVOE:

In her Interim Order Setting Deadlines for Motions, Responses to Motions, and Status Report, ALJ Emily DeVoe ordered the following:

"That parties shall file any appropriate motion by January 24, 2024."

FirstEnergy filed a Motion of FirstEnergy Pennsylvania Electric Company on behalf of its Met-Ed Rate District for Summary Judgment ("Motion") dated January 24, 2024. In her Certificate of Service, Tori Giesler, certified that she served the Complainant by electronic mail on January 24, 2024. On the Certificate of Service, no electronic mail is listed for the Complainant and no electronic mail was received by the Complainant.

Instead, the Motion was sent by US mail to the Complainant. The attached Exhibit 1, which is a copy of the FirstEnergy envelope used to send the Motion, shows the postage mark dated January 25, 2024. In fact, the Complainant received the Motion on January 27, 2024.

FirstEnergy failed to meet the required deadline to file any appropriate motions by January 24, 2024 when the Complainant was not served until after this

deadline. Furthermore, FirstEnergy submitted a false Certificate of Service when Tori Geisler certified that the Complainant had been served by January 24, 2024.

Complainant's Answer is filed within the 20 days after the date of service, as allowed under the Notice to Plead, as stated in the Motion. Complainant is entitled to a hearing under the PUC regulations.

WHEREFORE, Complainant respectfully requests Administrative Law Judge Emily DeVoe to dismiss FirstEnergy's Motion.

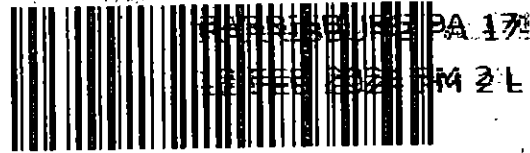

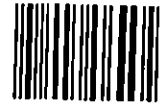
