PECO Energy Company ("PECO"), pursuant to 52 Pa. Code §1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. A telephonic hearing in this matter is scheduled to take place on Wednesday, March 13, 2024 at 1:00 p.m.
2. PECO is requesting a two (2) week continuance of the March 13, 2024, hearing date because Respondent's witness, Ramona Milburn, who is the regulatory assessor assigned to the case is unavailable. The witnesses' mother passed away yesterday and she is unavailable to testify in the Complainant's case.
3. PECO therefore respectfully requests a continuance from the Hearing date.
4. This is the respondent's first Continuance request in this matter.
5. The Prehearing Order in this matter states that requests for a continuance are only granted where "good cause" exists.
6. PECO avers that "good cause" exists to continue the scheduled hearing to another date because PECO's witness is the assigned regulatory assessor who has investigated the Complainant's case. She is the only witness available to testify to PECO's findings.
