

3. Reference Application, Section 10, Verifications, Acknowledgements, and Agreements – Applicant stated Calpine Energy Solutions, LLC is a registered PJM LSE. Please provide proof of a contractual arrangement with Calpine Energy Solutions, LLC to facilitate the retail electricity services.
4. Reference Application, Section 11, Affidavits – The Affidavits submitted have abbreviations for the company name. Please resubmit the Application Affidavit and the Operations Affidavit with the legal name and no abbreviations.
