### History

1. On January 21, 2024, Complainant filed a Petition to Reopen the current proceeding for the purpose of submitting additional evidence.
2. This Petition to Reopen cited 52 Pa. Code:

(a) At any time after the record is closed but before a final decision is issued, a party may file a petition to reopen the proceeding for the purpose of taking additional evidence.

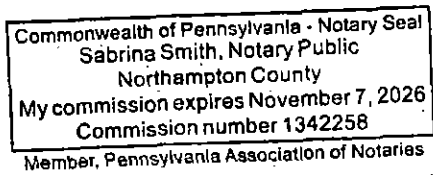

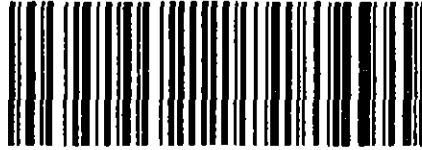
