
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 2 - 8 hours minimum transportation charges plus applicable travel time charges for Sundays and Holidays.

NOTE 3 - 5 hours minimum transportation charges plus applicable travel time charges for Monday-Saturday.

NOTE 4 - If services requested by shipper after 5:30PM, Monday-Friday, rates shall be on a time and one-half basis in Column 2.

NOTE 5 - When distance from carrier's terminal to point of origin and from destination back to carrier's terminal is:
