Request for Information

- 1.) In your application you state that you have been in operations since 2016 providing loading/unloading service for individuals and as a third-party vendor in conjunction with ABF trucks. Can you provide evidence of the jobs that you have performed, as well as the time frame for when this work took place.
- 2.) You failed to answer question #5 of the Verified Statement of Applicant. Please provide:
  - a. Your hiring system for drivers;
  - b. Your system for conducting criminal background checks;
  - c. Your driver training program;
  - d. Your system for conducting driver license checks;
  - e. Your policies regarding drug and alcohol use by your drivers.
- 3.) In your application you stated that you intend to rent vehicles from Enterprise Truck Rental, however, upon certification there is nothing that would stop you from providing your own vehicles for this household goods authority. Therefore, the Commission needs to know that you have an appropriate vehicle safety program should ever that change. Please provide this Commission with a description of what would be your vehicle safety program. Also, please include in your explanation:
  - a. Your periodic vehicle maintenance plan.
  - b. Your system for ensuring your vehicles will continuously comply with applicable Pennsylvania vehicle equipment standards (67 Pa. Code, Chapter 175).
- 4.) The Statement of Financial Position (Balance Sheet) submitted appeared to include financial information that was not solely for the LLC, such as vehicles when none were listed in the application. The Statement of Financial Position should only list the assets and liabilities that are in the name of the LLC, and not personal assets or liabilities. Please provide bank statements for the LLC, that show current cash and other assets, as well as any short term and long term liabilities.
