Reconsideration of Opinion and Order

My Name is Florence Ackridge, born and Raised in the city Of Philadelphia attended the schools of the city of Philadelphia have a master degree from Antioch University. Retired from the City of Philadelphia in 2006 as a Professional Social Worker. I am 84 Years old, disabled and live alone. My house holds expenses: Have a mortgage, mortgage and life insurance, special food, gas, electric and water bills, home repairs, disabled dog, a caregiver and other expenses. Unfortunately, I am not a lawyer and could not respond to or quote the law as you a judge. Don't hold this against me.

Yes, I Have stated and still do and don't understand how PGW charges heat for the summer months when the heat is not on.

PGW turned my gas off In November 1, 2001. I did not have any heat on in my home until the heater hot line Called and told me that they would send a contractor out which they did. Oval Heating has a contract with City of Philadelphia and works for the City. The came out to my home in January 2022 and submitted a letter stating that the heat was not on and the meter was not working. Took over 50 pictures to show that I was using heaters and picture of the meter. The judge is so adamant about the meter was working when I had submitted a letter requesting and paid the fee for a new one and that did not work. I had a televised meeting with Oval heating and Legal Eagle which Oval Heating took Over 50 Pictues of work done in my Home. No I should not be charged for heat that was not Done.

In March my son smelled gas and called PGW. They Came Out and turned the gas and told me to call an HVAC company who replaced the heater and boiler and put new pipes and charged me \$18,000. About several weeks after the Heater Hotline called and told me that were gong to put in a new heater for me and I told them they called me too late that another HVAC came and overcharged me \$18,000. I never indicated that PGW came out on the November 10 and shut my gas off my gss has been on since Green sky came out.

Unfortunately I only have a 3 days to respond. However, was to enclose correspondence from a check that was written out to PECO and Peco sent it to PGW who endorsed, te check and deposited into the bank of America.

Also I Want to note that the sitting Judge Marta Guhl was not at 801 Market Street because a dog came in the room and started to bark several times and the room was quiet until she came back on the mike the records indicated a pause. Ran out of time had more yo say
