- 1.) In your application you stated that you provided labor help (loading/unloading) for 2 plus years. Can you provide any evidence for the jobs that you performed, and the type of loading/unloading work that you did? As well as the time frame for when this work took place.

Additionally, I have attached photos highlighting helping customers loading items in to their rented trucks, wrapping furniture and placing them safely into the truck, and packing items in the home in preparation for customers' move day.

- 2.) Your answer to the question of how you will maintain records of the criminal background checks performed does not comply with Commission regulation. Please review Title 52 Pa Code §29.505 for record retention and provide a policy on how your criminal record checks will be maintained that complies with this regulation.

After carefully reviewing Title 52 Pa Code §29.505, I understand and will do the following:

- (1) Obtain a criminal record from the Pennsylvania state police and every other state in which the person has resided in the last 12 month.
- (2) Review each drivers criminal history every two years from the date of the last check
- (3) Review and not permit anyone to operate a vehicle if they have been convicted of a felony or misdemeanor to the extent the conviction would prevent the driver from performing the job safely and legally
- (4) Maintain a copy of the authorized drivers criminal history for at least 3 years

- 3.) Your answer to the question of how you will maintain records of the driver history checks performed does not comply with Commission regulation. Please review Title 52 Pa Code §29.504 for how long driver history checks should be retained and provide a policy on such that complies with this regulation.

After carefully reviewing Title 52 Pa Code §29.504, I understand and will do the following:

- (1) Obtain and review the drivers history in every state they held an operator's license or permit in the past 3 years
- (2) Upon receiving the original report, obtain a report of their driving history every 12 months since the last report
- (3) Ensure the drives hold a current/valid driver's license

(4) Maintain a copy of the drivers history for at least 2 years
