NOTE 1 - Minimum Transportation Charge: Sundays & Holidays (any hour), and Monday-Saturday, (5:01PM to 7:59AM): 6 hours at rates named in Column 2 plus applicable travel charge - Monday to Saturday, (8:00AM to 5:00PM): 2 hours at rates named in Columns 3 or 4 plus applicable travel charge.

NOTE 2 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

NOTE 3 - When a holiday falls on a Saturday, rates named in Columns 1 and 2 shall be applicable.

NOTE 4 - When a piano (any type) or a safe (weighing over 200 pounds) is included in the shipment, an additional handling charge of \$125.00 per item will apply in addition to all other applicable charges. Additional charge per flight for a piano or safe is \$75.00.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

This additional booking commission will not be levied upon any shipment sold by and booked by the Armstrong Relocation Company, Pennsylvania, LLC t/a Jack Treier Moving & Storage sales force.

HANDLING FEE

Carrier will add a 3% handling fee to the final charges when the customer chooses to pay with a credit card.

▲ FULL-VALUE PROTECTION

In lieu of rates shown in Tristate 50-T (Rule 38) & Tristate 51-W (Rule 47) for Full-Value Protection, the following rates will apply:

No Deductible Option - \$0.85 per \$100.00 of Value Covered \$500.00 Deductible Option - \$0.60 per \$100.00 of Value Covered

Full-Value Protection is subject to a Minimum Value Covered of \$6.00 per estimated/actual pound or \$10,000.00, whichever is greater.
