Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective May 1st 2024, for Zody's Moving & Storage, Inc. (PA PUC Certificate #A-00101820) in Waynesboro PA.

This filing is a request for an **INCREASE** in local hourly rates, a **CHANGE** in minimum transportation charges, a **CHANGE** in the packing/unpacking schedule for shipments transported 40 miles or less and shipments transported in excess of 40 miles, a **CHANGE** in labor rates, extra pickup/deliver schedule, overtime loading or unloading rates, and the schedule for elevator, stair carry & excessive distance for shipments transported in excess of 40 miles, and an **INCREASE** in container charges for shipments transported 40 miles or less and in excess of 40 miles.

PLEASE DELETE 7TH REVISED PAGE 111 AND ORIGINAL PAGE 112 AS THESE PAGES ARE NO LONGER APPLICABLE IN TRISTATE 54.
