- 1.) You failed to adequately answer all aspects of question #5 of the Verified Statement of Applicant. Please review Title 52 Pa. Code §29.501-509 Driver Regulations to see what is required of motor carriers.
 - a. Your system for conducting criminal background checks?
 - i. How will you maintain records of the criminal background checks performed?
 - b. Your system for conducting driver license checks/driver history?
 - i. How will you obtain driver license/history checks?
 - ii. How often will these checks be performed?
 - iii. How will you maintain records of such checks?
- 2.) In the Statement of Financial Position (Balance Sheet) submitted, you indicated that you have \$61,490 in current liabilities due within a year. Is this accurate? If so, this would suggest that your debt-to-equity ratio is 2.24. Are these payments structured, and if so, how? Please provide projected earnings for the next 12 months, and how these earnings will be able to service this debt and continue to provide safe and reliable service to the public.
