Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective May 1st 2024, for Simonik Transportation & Warehousing Group, LLC (PA PUC Certificate #A-899779) in Levittown PA.

The attached pages are 635th Revised Page 2, 88th Revised Page 2-C, 6th Revised Page 92-B, 2nd Revised Page 92-B-1, 1st Revised Page 92-B-2, 2nd Revised Page 92-B-3, and 2nd Revised Page 92-B-4.

This filing is a request for an **INCREASE** in local hourly rates (Peak & Non-Peak) for shipments transported 40 miles or less; the **ADDITION** of an overnight holding fee, handling fee when charges are paid by credit card, a warehouse dock fee and access charge, and a residential protection charge; a **CHANGE** in the application of travel time charges; a **CHANGE** in storage-in-transit charges; and an **INCREASE** in transportation charges (Peak & Non-Peak) for shipments transported 40 miles or less and in excess of 40 miles.

The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

The Issue Date for these changes in Tristate 54 is March 29th, 2024, with an Effective Date of May 24th, 2024.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (Non-Peak Season & Peak Season): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 4 hours (Non-Peak Season) and 6 hours (Peak Season) at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 4 hours (Non-Peak Season) and 6 hours (Peak Season) at rates named in Columns 1 and 3.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at the first point of origin until completion of unloading and dismissal of vehicles and men at the final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

NOTE 6 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable. MLK Day in January will be considered as a NATIONAL HOLIDAY in addition to NATIONAL HOLIDAYS shown in tariffs, Tristate 50-T and Tristate 51-W.

NOTE 7 - Rates and Schedules shown for Chester County in tariffs, Tristate 50-T and Tristate 51-W, will apply when service is performed anywhere within the Commonwealth of Pennsylvania. Shipments transported in excess of forty (40) miles are subject to a 4,000 pounds minimum weight.

▲ NOTE 8 - OVERNIGHT HOLDING when requested or required in lieu of storage will be an additional cost of **\$282.00** per truck per night.

▲ NOTE 9 - A **3%** handling charge will be added to the total charges when a customer chooses to pay using a credit card.

▲ NOTE 10 - A dock fee of **\$375.00** (flat charge) will be assessed when customer or another carrier picks up shipment from carrier's facility.

When a customer requests access to a storage container, an additional handling fee of **\$60.00** per man per hour will apply.

▲ NOTE 11 - A Residential Protection Charge of **\$20.00** (covers the cost for residential protective materials) will apply on all shipments.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.
