| <small>Total reportable gathering mileage was reduced from 42.1 miles in 2022 to 27.7 miles in 2023. - CHK divested the Gerbino system in 2023. This system had approximately 8 reportable miles (3.3 miles of Class 2 gathering), and was located in Bradford County. - CHK operates several low-stress, inactive gathering systems. A Class Location analysis using a buffer larger than 150' (as outlined in 192.8, Table 1) revealed that none of it qualified as Type B, Class 2 gathering. The result is CHK is reporting 0.0 miles of Class 2 gathering for 2023, rather than the 5.5 miles in Fayette and Somerset counties in 2022.</small> | |




