And please be aware that as a paratransit carrier you are unable to enter into a lease agreement with your drivers, and you are also unable to have drivers utilize their personal vehicle in this operation.
  
- 2.) Your answers to record retention for criminal background checks and driver history checks fails to comply with the regulations found in Title 52 §29.505(a)(4) and §29.504(a)(3) respectively. Please revise your policy for record retention of criminal background checks and driver history so that it complies with the aforementioned regulations.
