**INTERIM ORDER
SETTING CONFERENCE BETWEEN PARTIES**

On or about February 21, 2024, Tiffany Houser (“Complainant”), filed a Complaint PPL Electric Utilities Corporation and American Power and Gas Company of Pennsylvania LLC (“Respondents”), at the above-captioned docket number. On or about April 2, 2024, Respondent PPL Electric Utilities Corporation filed an Answer to the complaint. On or about April 3, 2024, Respondent American Power and Gas Company of Pennsylvania LLC filed an Answer to the complaint.

Based upon a review of the information contained in this material, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the Complaint and, if so, whether Complainant wants to withdraw the Complaint. Respondents shall contact Complainant concerning a mutually convenient date and time for Respondents and Complainant to hold a conference. The conference shall take place on or before May 3, 2024, unless this is not possible.

Within ten (10) days following the conference, Respondents shall file a short report with Cynthia Lehman (“Mediator”), setting forth:

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
- (c) A statement on the results of the conference.
