Application of the Department of Transportation of the Commonwealth of Pennsylvania for approval to perform preservation work on the existing bridge where State Route 0079 crosses the tracks of CSX Transportation Inc, DOT No. 584 829 W and Norfolk Southern Railway Company DOT No. 507 463 C in Robinson Township, Neville Township and Glenfield Borough, Allegheny County and the allocation of costs incident thereto.

To Whom It May Concern:

A final inspection conducted by a Commission staff engineer on April 2, 2024 revealed that all work has been completed in accordance with our Secretarial Letter dated September 30, 2019, and that all outstanding matters have been satisfied.

No party present at the April 2, 2024 final inspection stated they were seeking any reimbursement for costs it incurred on the project. We have carefully reviewed the record of this proceeding and all outstanding matters have been satisfied by the parties.

The Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code and finds that since all work has been completed, the case be "CLOSED."

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.

All formal documents must be filed with the Secretary of the Commission. Documents must be eFiled, mailed or hand delivered. If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
