We would appreciate it if you would communicate any objections you may have to these interrogatories as soon as possible.

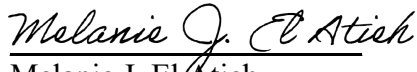

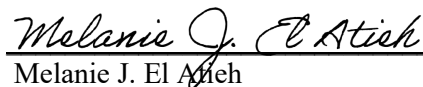
