On March 10, 2024, Great American Power, LLC, Utility Code 1112866, filed with the Pennsylvania Public Utility Commission (Commission) a Notice for Assignment of its Electric Generation Supplier license customers to Powervine Energy, LLC, Utility Code 1121434. In order for us to complete our analysis of your filing, and in compliance with 52 Pa. Code § 54.34 and/or 52 Pa. Code § 62.105, the Energy Industry Group requires answers to the attached question(s).
