In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for traveling between points in the Counties of Berks, Bucks, Chester, Delaware, Montgomery and the City and County of Philadelphia and transported distances of forty (40) miles or less.

Subject to Notes 1 to 4 below, the hourly charges are portal to portal based on the travel time from carrier's terminal to the first point of origin, continuing during all loading, transportation from the first point of origin, as well as any extra stops, to the final destination, unloading and dismissal of vehicle and moving crew at the final destination) and the return from the final destination to the carrier's terminal. For the convenience of the customer and the carrier, the travel time from the final destination back to the carrier's terminal may be calculated using a software package designed to calculate mileage and travel time, such as, Google Maps, MapQuest or TruckRouter.
