Pursuant to the Pennsylvania Public Utility Commission's Order entered on March 21, 2023 in the above-referenced matter, PECO Energy Company ("PECO") hereby submits this letter to indicate that PECO did not receive any funding deriving from the federal Infrastructure Investment and Jobs Act ("IIJA") in calendar year 2023.

While PECO did not receive any funding from IIJA in 2023, on October 17, 2023, the U.S. Department of Energy Grid Resilience and Innovation Partnerships ("GRIP") program awarded PECO a grant of up to \$100 million, contingent upon a successful award negotiation. PECO will report any actual receipt of funding derived from the GRIP award during the calendar year in which it is ultimately received.
