On March 21, 2024 an Order was issued after a Prehearing Conference was held.

That Order states Complainant is bound by new terms under regulation at 52 Pa.

Code § 5.245(a). 52 Pa. Code § 5.245(a) begins with the requirement of;

“(a) After being notified,”. Complainant was not notified of Prehearing Conference.
