Petition of PPL Electric Utilities Corporation for Approval of a Default Service Program and Procurement Plan from June 1, 2025 Through May 31, 2029

Docket No. P-2024-3047290

PETITION TO INTERVENE OF SHELL ENERGY NORTH AMERICA (US), LP

Pursuant to Sections 5.71 through 5.74 of the Pennsylvania Public Utility Commission's ("PUC" or "Commission") Regulations, 52 Pa. Code§§ 5.71 - 5.74, Shell Energy North America (US), L.P. (together with its operating subsidiaries, "Shell Energy") hereby files this Petition to Intervene in the above-captioned proceeding.¹

PPL Electric Utilities Corporation ("PPL" or the Company") has petitioned the Commission for approval of the Company's sixth Default Service Program ("DSP VI"). PPL's Petition for Approval of DSP VI (the "Petition") outlines, *inter alia*, the Company's proposed procurement plan, implementation plan and contingency plan for acquiring default service energy supply for all PPL customers who, upon expiration of DSP V on May 31, 2025, do not take generation service from an alternative electric generation supplier ("EGS") or who contract for energy with an EGS, which is not delivered. *Petition of PPL Energy Co.for Approval of its Default Serv. Program for the Period from June 1, 2025 through May 31, 2029*, Docket No. P-2024- 3047290, at 1.

In support of its Petition to Intervene, Shell Energy asserts the following:

1. The proposed DSP VI would apply to all retail customers in PPL's service territory, including customers of Shell Energy.

¹ As used herein, "Shell" refers collectively to Shell Energy North America (US), L.P. and its retail subsidiaries. Shell Energy has overall responsibility for the business activities of its retail subsidiaries, which serve residential, commercial, institutional and industrial customers in Pennsylvania's retail electric and gas markets.

2. Shell Energy is an indirect subsidiary of Shell Oil Company, which itself is an indirect subsidiary of Shell plc. Shell Energy conducts business in the electric and natural gas markets throughout North America, including within PJM Interconnection, L.L.C. ("PJM") territory. Shell Energy works with utility providers to deliver gas and power to customers in Pennsylvania. Shell Energy is a participant in the Default Service Program and state-licensed electric generation supplier in Pennsylvania. Consequently, Shell Energy has a substantial interest in and will be directly affected by the outcome of this proceeding.

The Commission's regulations allow intervention where a person has an interest in the proceeding which may be directly affected and which is not adequately represented by existing parties, and as to which the person may be bound by the action of the Commission in the proceeding. 52 Pa. Code § 5.72(a)(2). Intervention is also permitted where participation of the person may be in the public interest. 52 Pa. Code § 5.72(a)(3). A "person" includes a corporation and an association. 52 Pa. Code § 1.8.

Shell Energy meets the standards for intervention set forth in 52 Pa. Code §
5.72(a). As Shell Energy is a participant as a supplier in the PPL Default Service Program. Shell

Energy's ability to supply customers in PPL's service territory will be specifically and substantially affected by the outcome of this proceeding, which will establish the terms and conditions under which PPL will acquire electric supply to serve its Default Service load from June 1, 2025 through May 31, 2029.

6. Shell Energy is concerned with issues that affect competitive markets in Pennsylvania, including the structure of the default service, the procurement and implementation of default service supply, utility affiliate participation, the product mix relating to default service supply and programs that could potentially harm or become a disincentive to create customized and innovative competitive retail electric products and services for its current and prospective customers.

7. Shell Energy intends to participate in this proceeding to the extent necessary to protect its interests and those of its customers. These interests cannot be adequately represented or protected by any other party.

8. As one of the nation's largest energy providers, Shell Energy's intervention is also in the public interest. Shell Energy possesses significant and unique knowledge, experience and resources with respect to the marketing of retail energy services, which will be helpful in developing a record on the reasonableness of the programs as presented. Moreover, without the opportunity to intervene, Shell Energy will be unable to participate in this proceeding but will nevertheless be bound by the actions taken by the Commission. Such actions may have a material impact on Shell Energy's operations, business and systems as well as its continued involvement in PPL's service territory as a active participant as a supplier in the Default Service programs.

9. Shell Energy continues to review the Petition and the accompanying direct

testimony and exhibits and has not yet definitively established its position on the matters presented therein. Shell Energy reserves the right to take positions and/or seek relief based on its review of the various filings, discovery responses or the positions taken by other parties in this proceeding,

10. The Commission's regulations permit intervention by a party that demonstrates an "interest which may be directly affected and which is not adequately represented by existing participants, and as to which the petitioner may be bound by the action of the Commission in the proceeding." 52 Pa. Code § 5.72 Shell Energy has a substantial and direct interest in this proceeding and satisfies the standards for intervention under these regulations. **WHEREFORE,** Shell Energy respectfully requests that the Pennsylvania Public Utility Commission grant this Petition to Intervene, providing Shell Energy with full-party status in this proceeding, as well as any other relief as it deems necessary.
