Please type them up for submission in a professional manner. Please make sure to completely answer all parts of all questions separately. It would be best to download the application and type into it. If you are unable to do so, please seek help to provide as much information as possible in order to move forward.
- 2.) Regarding question 10 of the application, very clear examples have been given about how to write a territory, please follow those examples to provide a correct one. If you need help, call Jerome Elliott and have materials in hand to make notes for properly putting your application together.
- 3.) Verified Statement question 2: What are you referring to, please provide a full and complete answer.
- 4.) Verified Statement question 3: Please provide full details about what company or companies you have worked for in the past with contact information for a representative from that company.
- 5.) Verified Statement question 5: Regardless of if the owner will be a driver, you must provide a full and complete program for your drivers, and provide full and complete answers to each of the 5 parts of this question.

- 6.) Verified Statement question 6: Please provide full details on the vehicle, it is assumed you mean 115,000 miles. Please be specific.
- 7.) Financial Statement: this statement must be dated within 6 months of the application date. Please provide a more complete picture of your finances.
