On March 28, 2024, Aqua submitted updates to its Beaver Falls Application to the Pennsylvania Public Utility Commission (“Commission”). The Commission’s Bureau of Technical Utility Services (“TUS”) thereafter withdrew its previously granted conditional acceptance of the Application on April 4, 2024 to further review the updates to the Application.


