This filing is a request for a **CHANGE** in the minimum transportation charges for shipments transported 40 miles or less.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

▲ NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 5 hours plus applicable travel charge at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (6:01PM to 5:59AM): 2 hours plus applicable travel charge at rates named in Columns 1 and 4. Weekdays (6:00AM to 6:00PM): 2 hours plus applicable travel charge at rates named in Columns 1 and 3. On shipments of household goods, in use, having a gross cubic measurement of 300 cubic feet or less (the equivalent of the contents of a one bedroom apartment or less), no minimum transportation charge will apply.

NOTE 5 - When a holiday falls on a Saturday or a Weekday, the rates named in Columns 1 and 2 shall be applicable.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 15 miles	1/2 hour
16 - 35 miles	1 hour
36 - 55 miles	1 1/2 hours
For mileage in excess of 55 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
