Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective May 28th, 2024, for Simonik Transportation & Warehousing Group, LLC (PA PUC Certificate #A-899779) in Levittown PA.

The attached pages are 642nd Revised Page 2, 89th Revised Page 2-C, and 1st Revised Page 92-B-5.

This filing is a request for an **INCREASE** in Full-Value Protection rates and the **ADDITION** of depository coverage for shipments in storage. The changes apply to shipments transported 40 miles or less and shipments transported in excess of 40 miles. The revision of 1st Revised Page 92-B-5 was overlooked by the carrier when they submitted rate changes last month.

The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

The Issue Date for these changes in Tristate 54 is April 26th, 2024, with an Effective Date of May 28th, 2024.
