PETITION FOR WITHDRAWAL OF FORMAL COMPLAINT

Pursuant to 52 Pa. Code § 5.94, the Pennsylvania Public Utility Commission’s (“Commission”) Bureau of Investigation and Enforcement (“I&E”), by its prosecuting attorney, files this Petition for Leave to Withdraw I&E’s Formal Complaint (“Complaint”). In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on December 7, 2023, by filing a Complaint alleging that Respondent was charging a flat rate for moving household goods rather than the tariff issued and approved for Respondent on November 16, 2023, in violation of 66 Pa C.S. § 1303 and 52 Pa. Code § 31.27(a).
2. On December 7, 2023, the Complaint was served upon Respondent by certified mail.
3. Attached to the Complaint was a Notice advising the Respondent that he must file an Answer within twenty (20) days of service of the Complaint.
4. On December 11, 2023, Respondent filed an Answer in response to the Complaint.

5. Based upon information provided by Respondent to I&E, the facts and circumstances of this case have changed.

6. In the interest of justice, I&E desires to withdraw the Complaint that was filed in this matter.

WHEREFORE, I&E respectfully petitions the Commission for leave to withdraw the Formal Complaint in this matter pursuant to 52 Pa. Code § 5.94.
