Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective May 28th, 2024, for George W. Weaver & Son, Inc. (PA PUC Certificate #A-00113547) in New Cumberland PA.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3, and 4).

NOTE 2 - Hourly rates (Columns 2, 3, and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 4 hours at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

NOTE 6 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 7 - Rates named in Columns 3 and 4 apply from 8 A.M. to 12:00 Midnight on any day when a higher rate is shown for the following day.

▲ NOTE 8 - When a Baby Grand, Grand Piano or Gun Safe (350 pounds or over) are included in the shipment, and additional handling fee of **\$250.00** per item will apply. If stairs are at either origin or destination, an additional fee of **\$100.00** per flight will apply. These fees are in addition to all other applicable charges.

NOTE AA - Applicable only on shipments when the distance from original point of origin to final destination is 20 miles or less, apply one (1) hour at the applicable hourly rates.

NOTE BB - Applicable only on shipments when the distance from original point of origin to the final destination is more than 20 miles but not exceeding 40 miles, apply one and one-half (1.5) hours at the applicable hourly rates.
