4. On March 20, 2024, Duquesne Light filed with the Pennsylvania Public Utilities Commission Supplement No. 71 to Duquesne Light's Tariff Electric – Pa. P.U.C. No. 25, requesting a base rate increase in Duquesne Light's electric distribution rates of approximately \$133 million.

5. IBEW Local 29 anticipates numerous issues being raised in this proceeding that will or may affect its interests as a representative of Duquesne Light's employees and retirees and as a customer of Duquesne Light. Issues may also be raised by various parties concerning the safety or reliability of Duquesne Light's service that will or may have a direct effect on IBEW Local 29 and its members employed by Duquesne Light.

6. No other party to this proceeding represents the interests of IBEW Local 29 and its members.

7. IBEW Local 29 intends to actively participate in this proceeding limited to such matters that affect its interests as a customer of Duquesne Light and the interests of its members as employees and retirees of Duquesne Light. Such participation may include the presentation of direct or rebuttal testimony and the cross-examination of witnesses presented by Duquesne Light and other parties to this proceeding.

WHEREFORE, International Brotherhood of Electrical Workers, Local 29 respectfully requests the right to intervene as an active party in this proceeding.
