EZ Transit provides services to assist independent healthcare agencies and other small businesses with transporting their employees to various job sites or picking up. Mr. Jackson was a driver that transported these individuals with some requiring wheelchair assistance. Mr. Jackson was trained and certified in wheelchair compliance. The owner, Ezra Cole, will be more than happy to talk about Mr. Jackson's experience while employed with this company, 412-607-7526.

Your system for conducting driver license checks; e. Your policies regarding alcohol and drug use by your drivers.

Transit4life Co utilizes one driver and feels that this is an appropriate number due to the size of their current business. When Transit4Life Co begins to hire new drivers, they will permit a person to operate a vehicle in its authorized service if that person is at least 21 years of age.

Transit4Life Co will verify that the driver is in good standing with the Department and maintain records for 4 years.

Transit4Life Co may not permit a person to operate a vehicle in its authorized service until they have obtained and reviewed a driver's history from Backgroundz, Checkerz or the appropriate agency of that state in which that person held a motor vehicle operator's license or permit during the preceding 3 years. Following receipt of the initial driver history report, Transit4Life Co will, at least once every 12 months from the date of the last report, obtain a driver history for each driver operating under our authority from the appropriate agency of the state in which the driver held an operator's license during the time period. Drivers with unacceptable records (DUI Alcohol convictions) will not be accepted unless that person has completed the appropriate classes and requirements. Drug and Alcohol tests will be administered on a random basis. If a driver fails these tests, they will be given the opportunity and education to remain employed and will be subjected to more frequent testing. A copy of the driver's history shall be maintained by Transit4Life Co for at least 2 years.

Transit4life Co may not permit a person to operate a vehicle in its authorized service until it has obtained and reviewed a criminal history record from the Pennsylvania State Police and every other state in which the person resided for the last 12 months. Following receipt of the initial criminal history record, Transit4Life Co will obtain and review a criminal history record for each driver operating under our authority from the Pennsylvania State Police every 2 years from the date of the last criminal history check.

Transit4Life Co may not permit a person to operate a vehicle in its authorized service when the person was convicted of a felony or a misdemeanor under the laws of the Commonwealth or under the laws of another jurisdiction, to the extent the conviction relates adversely to that person's suitability to provide service safely and legally. A copy of the criminal history shall be maintained by Transit4life Co for at least 3 years.
